The Babasaheb Bhimrao Ambedkar Bihar University, Muzaffarpur is a State University in India. Began in 1952, the university initially functioned from the Mohanpur House at Sara Mohanpur Village of Darbhanga-Sakri route. In 1975, it was shifted to the campus belonging to Raj Darbhanga.

The University is in Muzaffarpur town, The university imparts education in fields such as humanities, social science, life science, commerce and medicine, with both undergraduate and postgraduate courses. More than 1000 faculties are engaged in teaching and research.

The institute has a residential campus of about 230 acres with modern facilities and support services for its students and faculty.
