MINIMUM QUALIFYING CRIREIA FOR VENDORS AS BELOW

- 1. Vendor should submit ITR for last 3 consecutive financial years.
- 2. Vendor should submit a copy of Permanent Account Number (PAN).
- 3. Vendor should submit the membership certificate of 'The Federation of Publishers' and Booksellers' Associations in India' (FPBAI).
- 4. Vendor should submit a valid office address proof.
- 5. Vendor should have an average annual turnover of Rs. 200Lakhs in last 3 financial years. CA certificate should be submitted.
- 6. Vendor should have an experience of supplying books to at least 5 Central/State Government Universities. Copy of purchase orders and relevant satisfactory supply certificate of last three years should be submitted.
- 7. Vendor has to submit two lakh rupees in form of DD as a refundable security deposit for the complete period of registration / empanelment. It should be in the name of Registrar, B. R. A. Bihar University, Muzaffarpur payable at P. N. B., Khabra Road, Branch, Muzaffarpur.

The registration / empanelment will be for three years from the date of issue of letter of registration of vendorship. It may be extended further more on the mutual consent of both the parties.
